3 **21 NCAC 34B .0309 LICENSE RENEWAL FORM**

4 ~~(a) To renew a funeral director, funeral service, or embalmer's license, the licensee annually shall submit a form~~
5 ~~provided by the Board, complete and submit to the Board a renewal application. The licensee shall designate whether~~
6 ~~the licensee is on active or inactive status pursuant to G.S. 90-210.25(a). A licensee designating active status shall~~
7 ~~furnish the licensee's current place of employment, work address and telephone number, any new criminal convictions~~
8 ~~since the licensee was licensed, continuing education hours, the signature of the licensee, and any information the~~
9 ~~Board deems necessary as required by law. A licensee designating inactive status also shall furnish the licensee's~~
10 ~~name, address and telephone number, any new criminal convictions since the licensee was licensed, the signature of~~
11 ~~the licensee, and any other information the Board deems necessary as required by law. The renewal form shall inform~~
12 ~~all licensees that licenses will be forfeited if not renewed by February 1. Failure to submit a completed renewal~~
13 ~~application by February 1 shall cause the licensee's license to be forfeited.~~

14 (b) The renewal form shall contain the following:

- 15 (1) The licensee's full name and license number;
16 (2) The licensee's physical address of personal residence, mailing address, and phone number(s);
17 (3) The licensee's current place of employment, work address, and telephone number;
18 (4) Whether the licensee's place of employment changed since the previous renewal application was
19 submitted;
20 (5) Whether the licensee is on active or inactive status pursuant to G.S. 90-210.25(2);
21 (6) Whether the licensee is requesting to be on active or inactive status pursuant to G.S. 90-210.25(2)
22 for the next year;
23 (7) Whether the licensee has been convicted of a felony or misdemeanor crime (excluding traffic
24 infractions) since the previous renewal application was submitted and, if so, a statement providing
25 the jurisdiction, charge, and disposition of each conviction;
26 (8) Whether the licensee has had an occupational or business license denied, suspended, or revoked by
27 any local, state, or federal agency since the previous renewal application was submitted and, if so,
28 a statement providing the reason for the denial and the date, location, and circumstances of any
29 violation that led to action against your license, the terms of any discipline imposed by the licensing
30 authority, and whether said terms have been satisfied;
31 (9) Whether the licensee has been subject to any investigation for employee misclassification since the
32 previous renewal application was submitted;
33 (10) Whether the licensee has received credit for attending at least five continuing education credits of
34 courses approved by the Board since the previous renewal application was submitted and, if so,
35 copies of all continuing education forms showing courses attending that have not been already
36 submitted to the Board;

- 1 (11) If the licensee is claiming an exemption from continuing education requirements, the basis for which
2 the licensee is claiming the exemption;
- 3 (12) The licensee's signature to certify that he or she has prepared the application and has read the
4 answers; that the information provided in the application is true; and that he or she has read the NC
5 Industrial Commission Public Notice Statement; and
- 6 (13) The application fee, as prescribed by G.S. 90-210.28 and 21 NCAC 34A .0201. If the application
7 fee is dishonored by the licensee's drawee bank for any reason, the Board shall suspend the license
8 until the renewal fees and non-sufficient fund charges are paid.
