
Licensees should review all documents on a regular basis and make the necessary and required changes to these documents when the merchandise prices and/or service charges change.

In addition, North Carolina law requires all items of merchandise offered in relation to a service by a licensee or establishment to have a card or brochure displaying the price.

#### **NEW POLICY MATTERS**

- On January 11, 2006 the Board adopted the recommendation of the Pre-need committee to pay interest on approved recovery fund claims at a rate of 1.5%. This was retroactive to January 1, 2006 and will apply to claims until the Board again reviews the policy.
- On February 8, 2006 adopted a modification to the policy on the right of the original contracting funeral establishment to withhold up to 10% of payments received for pre-need contracts transferred to another establishment. That modified policy, as reflected by the change in the text of the pre-need manual, appears in the Pre-need section. In a related action the Board approved a correction to the pre-need manual to accurately reflect any amount withheld is computed on the <u>total of payments received for deposit</u>, **NOT** on the entire trust account balance. The pre-need licensee is not entitled to withhold any percentage of the interest growth accumulated in the trust.

#### **CREMATION**

Due to concerns over the documents required for cremation of the bodies of cases under investigation by the medical examiner the North Carolina Crematory Authority reviewed the concerns and recommended to the Board that a statement be issued to clarify the matter. In deaths coming under full investigation by the Office of the Chief Medical Examiner, the burial transit/cremation authorization form (the yellow page of the Medical Examiners Certificate of Peath) is to be used to effect the cremation of the decedent. The white face page of the Medical Examiners Certificate of Death is <u>not</u> an additional requirement.

Minimum information required on a death certificate: Pursuant to North Carolina law (NCGS 90-210.129), in deaths certified by the attending physician, the following minimum information shall be included on the death certificate: Decedent's name; date of death, date of birth, sex, place of death; facility name (if not institution, give street and number), county of death, city of death and time of death if known.

#### NC CREMATORY AUTHORITY

On Thursday, March 16, 2006 the NC Rules Review Commission approved 21 NCAC 34C .0101 the permanent rule for Crematory Authority elections. The effective date of the permanent rule was April 1, 2006.

#### PRE NEED

The excerpt below (changes are underlined in italics) represents the revised text of the pre-need manual pursuant to the Board actions adopted during the February meeting. The revised pre-need manual may be accessed via the website.

"For transfers prior to death, the original contracting preneed licensee may withhold up to 10% of the <u>payments received for deposit</u> if the original contract is dated between July 10, 1992 and September 30, 2003, the licensee did not withhold any funds at the time of the original contract, and the right to withhold these funds is disclosed on the contract <u>by completion of the appropriate section on the front of the contract</u>. For transfers after death, the original contracting preneed licensee may withhold up to 10% of the <u>payments received for deposit</u> if the original contract is dated between July 1, 1993 and September 30, 2003, the licensee did not withhold any funds at the time of the original contract, and the right to withhold these funds is disclosed <u>by completion of the appropriate section on the front of the contract</u>."

Licensees should review practices from time to time to ensure pre-need documents are fully and correctly completed prior to filing with the Board. The staff has compiled a list of the most common issues:

- Legibility of contracts- when completing a contract by hand, please print clearly. Illegible handwriting can delay contract registration or cause the entry of incorrect information.
- Completion of required areas on pre-need documents- certificate of performance: date and amount of payment. If waiting for payment from multiple funding sources list the date and amount of first payment received and the other sources from which payment is expected.
- Completion of required areas on pre-need contracts- obtain the purchaser's initials indicating whether the contract is revocable or irrevocable. This means initials, not some other type of mark unless the purchaser is unable to write his or her initials. In addition if the purchaser makes any payments in the form of cash or check enter the amount paid, even if the check is made payable to an insurance company or bank.
- <u>Complete</u> copies of contracts- Front AND back of contracts should be copied when filing with the Board.

#### Statutory deadlines for pre-need:

- Deposit funds or purchase insurance policy within 5 business days of contract date.
   (NCGS § 90-210.61 page 26, NC Funeral Service and Cremation Laws, 2005 Edition)
- File the pre-need contract and contract registration fee within 10 days of the contract date. (NCGS § 90-210.67 page 32, NC Funeral Service and Cremation Laws, 2005 Edition)
- File the certificate of performance within 10 days of receiving payment. (NCGS § 90-210.64 page 29, NC Funeral Service and Cremation Laws, 2005 Edition)
- On contract fulfillment, proceeds of a pre-need trust account must by distributed according to the terms of the contract within 30 days.
   (NCGS § 90-210.64 page 29, NC Funeral Service and Cremation Laws, 2005 Edition)
- Pre-need annual reports are due by March 31 for the preceding year ending December 31. (NCGS § 90-210.68 page 34 and 21 NCAC 34D .0302 page 136, NC Funeral Service and Cremation Laws, 2005 Edition)

#### PANDEMIC FLU RESPONSE PLAN

The Board is participating in the Pandemic Flu Response Plan being developed by the NC Division of Public Health. The outlook by health experts is this not a matter of "if" but "when".
