The Board of Funeral Service continues to monitor activity of the North Carolina Legislature during the 2014 short session. Bills before the Legislature which if passed will impact funeral service: H660 (Amend Funeral Procession Law), H808 (Merge NCBFS and Cemetery Commission), H811 (Amend Practice of Funeral Service Laws) and S403 (Investments/Cemeteries/Funeral Funds). CASE FILE NUMBER: M14-005.

LICENSEES: Casey Funeral Home, Princeton (FE #89); Martha Casey (FSL #1892); Craig Casey (FSL #1215).

SUMMARY: Casey Funeral Home, Martha Casey, and Craig Casey, the manager at the time of the violations, were placed on probation for mishandling preneed funds under a consent order. The Board received additional cases of mishandling preneed funds.

BOARD ACTION: The Board entered into a consent order revoking the funeral service license of Martha Casey and barring her from the firm. The Board renewed the probation for Craig Casey and Casey Funeral Home for five (5) years.
