The North Carolina Legislature is back in session for the "short session." Several bills are before the Legislature which if passed will impact funeral service: H660 (Amend Funeral Procession Law), H808 (Merge NCBFS and Cemetery Commission), H811 (Amend Practice of Funeral Service Laws) and S403 (Investments/Cemeteries/Funeral Funds), along with others which would impact cemeteries and columbaria.
