### LAWS AND RULES REVIEW:

Cremation Authorizing Agent Time Limits  
Authority: §90-210.124(b) Authorizing agent.

The Board staff regularly receives phone calls from licensees asking about "the ten-day rule" as it relates to cremation authorizations. The statutory citation is below:

(b) A person who does not exercise his or her right to dispose of the decedent's body under subdivision (a)(2) of this section within five days of notification or 10 days from date of death, whichever is earlier, shall be deemed to have waived his or her right to authorize disposition of the decedent's body or to contest disposition in accordance with this section.

If there is an individual whose signature is required on the authorization (see Laws & Rules Review in the December 2014 e-Newsletter or p. 182 in your green law book) but they are out of state, whereabouts uncertain, incarcerated etc. you cannot just wait for the ten-day period to elapse and then proceed without their signature. You must demonstrate due diligence in your efforts to obtain the signature(s).

What constitutes due diligence? Phone call logs and copies of e-mails: to who(m), dates and times; Facebook and Twitter searches (to who(m), dates and times); newspaper ads in the legal notices or obituary sections in the subject's last known whereabouts and copies of the ads for the file. You should *never* rely solely on "the family told me they did it." If the family member is deployed with the military, the American Red Cross can assist with getting the paperwork to the service person for signature. If the individual(s) is/are incarcerated, the Department of Correction will assist in obtaining the signature(s).

If the proposed signatory opts to waive their right, they must do so in writing and cannot direct any individual to act on their behalf. They can only waive their own right to sign.

Finally, if an individual with signatory rights is notified of the death and fails to take any action within five days of notice, they have abdicated their right to sign and you would no longer require their signature. However, you must document all of your efforts to have obtained the signature.

There were 9,427 cremations performed in North Carolina in the first three months of 2014. By contrast, 10,295 were performed in the first quarter of 2015...an increase of 9.2% year-to-year.
